1.1 Functionality availability restrictions in T7 Release 6.0

1.2 General functionality restrictions in T7 Release 6.0

The following table provides a general overview of the current functionality restrictions within the T7 Release 6.0 software.

1	Xetra	Xetra BEST	The functionality of new account for risk less principle flow is not available
2	Xetra	Xetra BEST	Currently there is no validation of the <i>maximum order quantity</i> while entering BEST Quotes
3	Xetra	Xetra BEST	In a BEST quote request, the trading capacity implementation is currently not available.
4	Cash & Derivatives	Stressed Market Condition (SMC)	After a SMC is detected, in some scenarios the SMC trigger will not be seen via market data or news alert.
5	Derivatives	Stressed Market Condition (SMC)	An SMC trigger in after a volatility interrupt does not work.
6	Derivatives	Stressed Market Condition (SMC)	The SMC trigger in functionality for related products is not available.
7	Derivatives	Selective Request for Quote Service (SRQS)	TES aggregation (in case of same requester, respondent and price level) is not available
8	Derivatives	Selective Request for Quote Service (SRQS)	GUI Alert functionality for SRQS is not fully functional.
9	Derivatives	Pre Trade Control	The validation of <i>maximum order value</i> is incorrect while entering a Option Volatility Strategy.
